Sealed Bid affixing non-refundable **Court Fee Stamps of Rs.2000.00 (Rupees Two thousand) only**, eventually to be drawn in F2 – form of agreement are invited in 2(two) covers bid system i.e. *Technical Bid* and *Financial Bid* by the undersigned on behalf of the Governor of Meghalaya from Class-I Meghalaya PWD Registered Contractors having own valid Electrical License and requisite qualification as per the eligibility **Criteria** of the Bid documents, for the execution of the following work as mentioned below and the same will be received in the office of the Undersigned (Room No.112) upto the **26<sup>th</sup> February 1014 at 2:30 P.M.** The Technical Bid will be open on the **same day at 2:45 P.M.** in the presence of the intending Bidders or their authorized representatives who so desire to witness the opening of the tenders. However, if such last date is declared as a holiday, then the next working day will be the schedule date for receiving and opening of tenders.


**Eligibility criteria:-**

- (a) The Bidder(s) should have satisfactorily completed during the last **3(three) years** of at least 1(one)work of similar nature and having a magnitude of **50%(Fifty percent – price updated @ 10% per annum compoundable)** of the value for which pre – qualification is sought or the Bidder should be satisfactorily executing currently at least 1(one) work of similar nature and having completed **billing not less than 50%** of the current value of work in any Government organization for which pre – qualification is sought.
- (b) **The average annual turn – over** of works over the last **3(three) financial years** shall not be less than **50%(fifty percent) of the project cost** against which the requisite certificates from the Chartered Accountant/Competent Authority has to be submitted along with the pre – qualification bid.
- (c) Non-Tribal contractors shall have to furnish the valid Trading License from the concern Autonomous District Council before purchasing of Bid documents, failing which no Bid documents will be issued.
- (d) The prospective tenderers or any of their constituent partner should not have abandoned any work nor any of their contract work should have been rescinded in the last 5 (five) years.
- (e) In case of Joint Venture, both the partners should submit trading license and labour license.
- (f) The available bid capacity of the prospective tenderers should be more than the project cost/tender value which will be calculated as per provision of the bid document.
- (g) Other information, terms and conditions will be as per Detailed NIT.
