Terms and conditions for the sale of Smoke Rubber Sheets and Scraps 2017-18 and 2018-19.

1. Court fee stamp worth Rs.1000/- (One Thousand) only should be affixed by the Tenderer without which no tender shall be accept.
2. The buyers, at their own interest, may like to inspect the stock at the respective godown of the Divisional Soil & Water Conservation Offices as indicated at Serial N.4 below.
3. The rate per Kg. should be quoted clearly in figure and in words (no over writing) separately for Smoke Rubber Sheets and Scraps for Marngar (Ri Bhoi), ,Tura, and Conservation Training Institute Byrnihat (Ri-Bhoi). Inclusion/exclusion of Taxes should be clearly mentioned.
4. The tender, if so desired can opt partly for (i) Garo Hills Stock(ii) Khasi Hills and Ri-Bhoi Stock separately but wholly for (i) or (ii).
5. The Director of Soil and Water Conservation will base the rate of Smoke Rubber Sheets and Scraps fixed by the Rubber Board from Kotayam. Hence the rate to be quoted should be at par/ below/above the above rate.
6. The floating rate to be accepted will be effective as on the date of accepting the tender.
7. Each and every intending buyer shall have to deposit an Earnest Money at the time of submission of the Tender in the form of D/Draft, Banker Cheque/(Cash not accepted)drawn in favour of the Director of Soil & Water Conservation, which will be released soon for the unsuccessful tenderer @10% for Non Tribal and for Tribal @5% of the total value of the Smoked Rubber Sheets and Scraps. The Earnest Money of the successful tenderer shall be retained and considered as security deposit and shall be released only after satisfactory completion of the work.
8. The Tenderer should enclose the latest clearance Certificate of Professional Tax, GST registration.
9. The tender should be accompanied with valid attested copy of Trading License/Certificate issued by the concerned Autonomous District Councils of Meghalaya, for Non-Tribal Firms, etc,
10. Attested Copies of valid Rubber Dealership Licences issued by the Rubber Board should be enclosed along with the tender.
11. The successful Tenderer shall have to deposit the whole amount of price at the rate to be fixed by the Director of Soil and Water Conservation immediately and only then lifting order will be issued. Lifting should be completed within one month from the date of acceptance of the tender from the Godowns of the respective Soil and Water Conservation Divisions located at Marngar, (Ri-Bhoi). ,Tura, and Conservation Training Institute Byrnihat (Ri-Bhoi). at their own expenses/arrangements. The cost of transportation of the materials from the respective godown of Divisional Soil and Water Conservation offices will have to be borned by the approved tenderer.
12. The successful tenderer shall be responsible for weighing for the Rubber Sheets and Scraps at their own expenses in the presence of the concerned Divisional Soil and Water Conservation officers or representatives before taking delivery and the Challan for the quantity delivered to be signed by the Divisional Soil and Water Conservation officers and the Approved buyer or his representative. The Director Soil and Water Conservation shall not be responsible for any loss/damage/theft of the materials after delivery from the offices/ godowns of the concerned Divisional Soil and Water Conservation offices whatsoever.

13. The Director of Soil and Water Conservation shall issue N.O.C.etc. for transportation within the State of Meghalaya only. Transportation papers etc. beyond the State lie solely with the buyer.
14. Non compliance by the successful tenderer as stipulated, offer shall be given to the next higher bidder without further communication and the Earnest money/ Security Deposit will be forfeited to the Government.
15. The Director of Soil and Water Conservation reserves the right to reject or accept any or all the tender without assigning any reason thereof.
16. The tenderer will have to sign a declaration form as mentioned below.
17. All terms and conditions as per the GST will be applicable.
